

ENHANCING COMMUNICATIONS AND CONNECTIVITY

CURRENT FISH REPORT

FMZ Zone 15 regulation changes – Kennisis Lake region

The Zone 15 Fishery Council and Ministry of Natural Resource 's representatives have now met some 20 times over the last 2 years to review a significant amount of data and propose changes to fishery regulations in Zone 15

Expectation is that the proposed regulations could be out for public consultation sometime in 2020

The goal is to have self-sustaining and growing populations of most species of Lake Trout

Regulations could see changes such as shorter seasons. slot limits and maximum keeper size limits to enhance the protection of this heritage fish which is one of the most vulnerable to rising lake temperatures related to climate change

Stay tuned for your opportunity to comment on any proposed changes sometime next year.



- The KLCOA board will continue with investigations and discussions about the following initiatives over the winter in order to continue with advocacy and education for the Spring.
- These initiatives have come about as a result of ongoing concerns raised by members.
- Shoreline erosion from boat wakes
 - No wake markers deployed
 - Education through e-blast, website and newsletter
 - OPP Marine division representative booked for Spring GM

Pesticide use around our Lakes

- Feedback question in the Spring 90% of over 100 respondents are in favor of the KLCOA doing something
- Investigation, discussions and debate
- Issue bigger than just permethrin
- Varying degrees of bans already adopted in over 180 municipalities in Canada
- Other Dysart Lake Associations are also looking into the use of pesticides of varying degrees
- Based on feedback, collected investigation results and our Lake Plan the KLCOA took broader approach and sent a letter to Dysart requesting a ban on all pesticides or a restriction covering wide, defined no application buffer zones along shorelines to reduce the risk of runoff to aquatic environments
 Letter is posted on our website
- In the meantime Dysart just passed a motion to leave the ban on Garlon in place and charged the Environmental Committee with looking at the broader issue of pesticides – public consultation will be part of this process of which the KLCOA can choose to participate
- Health Canada has just released it's final decision on Permethrin Re-Evaluation – both summary and full document are available on our website





- Short-term cottage rentals and their effect on our Lakes
 - In process of collecting members responses to feedback question
 - We will review these over the winter and decide on an education/advocacy plan

- ABANDONED DOCKS
- WINTER DOCK STORAGE CONSIDERATIONS!
- As you start to think about the Fall and storage of your docks please consider the following:
- Docks stored for the winter in bays around the Lake are expected to be removed each summer.
- If you plan on replacing your dock in the spring with a new dock please consider gifting or selling your old dock or have your dock company remove and dispose of it. Do not abandon it in a bay.
- Please consider marking your dock with identification so you can be contacted if it escapes over the winter or if there is a concern about it in the early summer.
- If you have previously abandoned a dock please consider having it removed and disposed of when you store your existing dock this winter. Most dock companies will do this service for a fee.

KLCOA Lands and Traditional Rights of Way



- Background
- A number of portage routes connect Kennisis to other lakes or rivers in the area
- Key portage routes are Lipsy Lake portage linking Lipsy Lake to Soap Pond on Kennisis
- Cat Bay portage connecting Cat Lake with Cat Bay on Kennisis
- Klaxton Lake to Lipsy Lake
- Dead Horse Bay portage linking Red Pine Lake to Dead Horse Bay on Kennisis (the Cat and Dead horse portages connect Kennisis with the Leslie Frost Recreation and HHWT)
- Tall Pines snowmobile trail

Multiple portage routes allow access to Frost Centre, Haliburton Forest + Algonquin and more



KLCOA Lands and Traditional Rights of Way

- Progress Update Summer 2019 Activity



Extensive legal research on key portages completed

- Reviewed in detail the Parcel Registers and surveys/plans for the three noted portages around Kennisis Lake;
 - Lipsy Lake to Kennissis Lake (Soap Pond)
 - Klaxton Lake to Lipsy Lake
 - Cat Lake to Kennisis Lake (Cat Bay)
 - We also sourced title documents to check certain details, particularly in transfers (deeds), original crown patents also sourced.
- Haliburton Echo Article on TROW project resulted in individuals coming forward with valuable knowledge of historical portage routes
- Interviews conducted with canoeists who used routes as far back as 1955



Historical Research – Kennisis Portages Routes used as far back as 1909

190 Drowning Accident.

A triple drowning accident took place on Keneese Lake, on Monday, June 14th, and the friends of R. Cruickshanks, jr.; E. McGurie and Archie Bird are mourning the loss of three noble hearted young men of West Guilford. On the day in question they started for the vicinity of Dorset by way of Keneese Lake canoe route. Apparently all went well until this lake, which is a very large one, was reached, when it would appear that their cances filled. No one knew of the accident at the time, and no search was made till after it was learned that they had not reached their destination and none had seen them. As they were all active young men it was yet hoped that they were safe, but no time was lost in making a search, which disclosed the fact that all were drowned. It was a sad and laborious task to portage the bodies home to their sorrowing friends, but it was accomplished. The two first named were married but eight and six months ago, respectively, to daughters of Mr. Wm. Henderson. The young men were all raised in West Guilford, their parents, brothers and sisters are there, and nearly every home in the community is in mourning. The funerals took place on Tuesday the 29th, R. Cruickshanks being buried at the English Church Cemetry, Maple Lake, while his two companions were interred in the Methodist Cemetry. A memorial service for all three will be conducted by Rev. H. S. Lloyd, at West Guilford, on Sunday evening, July 4th, at 6.80 p.m.



Cat Lake and Lipsy Lake Portages conform to Public Lands Act and are traversable




- Lipsy Lake to Soap Pond this portage crosses 5 parcels of land 4 that are public (municipal land) and 1 private lot. The deed to the private property includes the express right to portage over this land.
- The Cat Lake to Cat Bay on Kennisis Lake Portage crosses 7 parcels of land including 2 private. The deeds to both private properties contain language that provides for the express right to portage over this land.

Both of these portage routes cross lands expressly subject to the right of portage

 Under the Public Lands Act one type of person authorized to cross over private lands is someone portaging a boat and their belongings from one body of water to another. The patenting and granting of lands from the Crown to private individuals is subject to the right of any person travelling on waters connected by a portage to pass over the portage with their belongings without the permission of or payment of the land owner. A person who hinders or obstructs such passage over a portage is guilty of an offence.

KLCOA Lands and Traditional Rights of Way Next Steps



- Develop advocacy/educational outreach program to ensure all interested parties are aware of their rights and responsibilities related to use of portage routes including portage signage
- Research indigenous use of portages routes from original crown survey notes and indigenous treaty documents
- Consider advocating for new municipal bylaws to keep ensure authorization to use the portage routes on public municipal lands, and include processes for public consultation should these routes be proposed to be changed or closed
- Explore the development of protocols with the municipality and MNR to retain access and monitor portage route use
- Understand enforcement of rights to portage liaise with office of Attorney General to obtain more clarity on dispute resolution process












TOTAL PHOSPHORUS RESULTS: Concentrations of Total

Phosphorus decreased during 2017 and 2018. Trigger Ranges for Total Phosphorus range between $4-10~\mu g/L$ meaning both lakes are oligotrophic.








CALCIUM RESULTS: Average May and June calcium concentrations for Kennisis and Little Kennisis Lake are currently above the threshold for zooplankton which is important for maintaining a healthy ecosystem.





What can I do to keep my Lake Happy?



- 1. Get your septic inspected.
- 2. Follow proper septic maintenance practices.
- 3. Keep a naturalized shoreline (20m vegetative buffer zone).
- 4. Plant native plants to protect your shoreline from erosion and storm water runoff.
- 5. Use erosion and sediment controls during construction.
- 6. Properly dispose of pet waste.



SEPTIC RE-INSPECTION PROGRAM UPDATE John Smith

Septic Re-Inspection Report

- Cottage Order
- As of July 31st 518 Inspection reports had been submitted and processed
 - 25% of these required repair/replacement
- As of today it is estimated that about 90% of required inspections have been completed
 - August likely the busiest month of the program
 - Some owners are delaying submission of their report in order to allow more time to complete the repairs
 - About 150 new systems were installed in the five years preceding the start of the program and so no inspection is required
- Significant penalties have been announced by Dysart for any property owner who fails to meet the Dec. 31/19 deadline
 - No exemptions will be granted

FOCA Septic Inspection Report



- Report recently released on re-inspection programs across
 Ontario
 - Voluntary programs do not work
 - Many communities have mandatory programs in place
 - Lake associations have been a primary driver
 - No "perfect" inspection approach identified
 - Education is a key component and helps extend septic life
 - Evaluated thousands of systems over many years

FOCA Septic Inspection Report



- Most failed inspections were due to:
 - Overuse
 - Improper maintenance
 - Driving vehicles over the distribution bed
 - Planting trees over the leaching bed (root damage)
 - Hooking up a water softener to the septic system
 - Age and/or improper installation

FOCA Septic Inspection Report



- Overload/leaking of sewage is a Big Problem
- "A septic system is designed to treat a set volume of wastewater. Every time water goes down the drain into your septic tank, the same amount of liquid leaves the tank and enters the leaching bed. If too much wastewater enters the tank—from extra guests, heavy water use—too much waste is forced out, too soon. Unsettled wastewater can leave the tank too quickly, including solids that can enter the leaching bed and clog up pipes."
